Type of classes: classes

Substantive content: the subject of the course in civil law will be to introduce students to the basic concepts of civil law in Poland, and then to make comparative legal studies with the legal systems of students' countries of origin

CLASSES: Introduction to civil law regulations: origins and objectives. Construction of Polish civil code in comparison with chosen civil codes of EU coutries. Important definitions (general clauses, legal events, good faith, subjective rights). Subjects and objects of civil law. Legal capacity and capacity for acts in law. Declaration of intend and its defects. Limitation of claims. Representation - concept. Power of attorney - types and form. Commercial Proxy. Practical application of gained knowledge. Law of property - the ownership (definition, limits, rights). Mutual relations among the owners of neighboring lands. Acquisition of ownership. Acquisition of ownership - continuation (usucaption, appropriation, finding a thing). Cases. Co-ownership. Protection of ownership. Perpetual usufruct. The comparison of law of property institutions. Limited proprietary rights: usufruct, servitudes, pledge, mortgage, cooperative member's ownership right to premises. Law of obligations - some general provisions: the obligation, the creditor, the debtor, the performance types of liability, sources of obligations. Principles of obligations: the freedom of contract, currency principle, nominalism, indexation principle, rebus sic stantibus. Interest - definition, types, rules. Preliminary contract. Unjustified enrichment. Torts. Consumer regulations. Proposition of The European Civil Code pros and cons, opinions (followers and opponents), future chances.
