#### Substantive content

CLASSES: Cultural heritage in spatial planning - analysis at the level of the country, province and commune. The analysis of planning documents in a selected commune from the point of view of cultural heritage protection  
Spatial conflicts - case study. Identification of spatial conflicts and ways of solving them. Civilizational and cultural conditioning of its shaping. Public services in the commune - scope, degree of implementation, e-administration. Defining the needs for public services in the commune.

LECTURES: Space as a good, object of shaping and use. Living conditions of the population - work, home, leisure. Social aspects of spatial planning. The social context of spatial development. Civilizational and cultural conditioning of its shaping. Sustainable development, ethics of space use. Spatial conflicts and ways of its solutions. Cultural heritage in spatial planning. The system of monuments protection in Poland. Public services. E-administration in Poland - current state and needs. Public services in the commune.

Learning purpose: Understanding the social and cultural contexts of spatial development.

Knowledge: Student knows social conditions of space management and system of monuments protection in Poland.

Skills: Student can analyze social aspects of spatial planning and can assess their impact on the space.

Social Competencies: Student recognizes the importance of social conditions in space planning.
