

**Veterinary surgeon in European Union and other countries****ECTS: 1.00****SUBJECT MATTER CONTENT****LECTURE**

Issues relating to the European integration. EU legislation regulating the profession of veterinarian in selected Member States will be discussed. Among the topics presented, there will be issues related to the employment of veterinarians from EU countries outside its territory. In animal matters, the EU animal health strategies as well as the animal identification and registration system will be presented. The issue of environmental protection will be discussed.

AUDITORIUM CLASSES

Getting to know the history of the European Union, the process of its creation and development. Issues related to the legislation in the field of veterinary medicine. European standards for the education of veterinarians, both at the stage of preparation for the profession and during its performance. EU legislation on the profession of veterinarian, including the provisions of the Code of Good Veterinary Practice. Students will be familiarized with job search and employment procedures in selected EU countries and third countries. Aspects of animal protection in the EU will be presented, as well as legal provisions concerning the movement of animals for non-commercial purposes within the European Union.

TEACHING OBJECTIVE

Bringing future veterinarians closer to the legal aspects of the profession performed in private veterinary practice and veterinary service in the territory of the Community and in third countries, with particular emphasis on the formal and legal aspect of getting a job in these countries and the subsequent performance of the profession. During the course, legal acts in the field of EU Veterinary Medicine and non-EU countries are discussed.

W1 – learning about the history of the European Union, the structure of its organs, the process of creating Community law, political, social and economic aspects of the creation and development of the EU

W2 – knowledge of the legal aspects of practicing the profession of a veterinarian in private practice and veterinary service in the EU and third countries

W3 – knowledge of the procedures and documentation required to work in both Community and third countries Skills U1 - looking for internships or work outside Poland

Skills:

TEACHING FORMS AND METHODS:

Auditorium classes(W1;W2;W3;U1;U2;K1;K2):multimedial presentation, didactic and panel discussion

FORM AND CONDITIONS OF VERIFYING LEARNING OUTCOMES:

Lecture (Oral test) - Verification of the achievement of learning outcomes in the scope of the material discussed in the lectures is an integral part of the test conducted as part of the classes, hence the description of the form and conditions for passing the exercises also apply to passing the lectures. -

Auditorium classes (Oral test) - There is 1 oral test per semester. The test mark is issued on the basis of the arithmetic mean value of the marks obtained for each question. The rounding of the evaluation is done on the basis of the following value ranges: mean \geq 4.76: very good (5.0); average in the range of 4.26 - 4.75: good plus (4.5); average in the range: 3.76 - 4.25: good (4.0); average in the range of 3.26 - 3.75: sufficient plus (3.5); mean \leq 3.25: satisfactory (3.0). The student may attempt to correct the test twice. The condition for receiving the final pass in the classes is to obtain a positive mark from the test (including all approaches). In the event of a top-down suspension of classroom classes and the need for online learning, the methods of verifying the achievement of learning outcomes declared in the syllabus, i.e. the forms of passing the exam and exercises, may change in a manner appropriate to the situation. -
