Substantive content

CLASSES: Milestones in economic history. Origin and development of history economy, development and economic growth. History of market economy and its institutional system. agricultural revolution. Feudalism. Great Geographical Discoveries - Consequences. Events ending the Middle Ages and beginning the modern era. Mercantilism. Agrarian and industrial revolution. Development of the institutional system of the market economy.

Economic dualism. Imperialism and economic nationalism. History of money and banking. Economic crises and their consequences. Economic transformation. The essence and causes of political and economic integration in Europe. Objectives and stages of European integration. The process of deepening and widening integration. Poland in the European Union - analysis of macroeconomic indicators. History of European integration, including monetary integration, analysis of macroeconomic effects. Historical conditions of economic development of selected countries.

LECTURES: The genesis and development of economic history, economic development and growth. History of market economy and its institutional system. Mercantilism, imperialism and economic nationalism. The development of capitalism and industrial revolutions. History of money and banking, development of currency systems. Economic crises. Outline of Main Currents and Economic Doctrines. Centrally planned economy, economic transformation. Economic globalization - determinants, essence, development. Regional economic integration. The essence and causes of political and economic integration in Europe. Objectives and stages of European integration. The process of deepening and widening integration. Poland in the European Union.

Learning purpose: Acquainting with the main threads of the economic history of the world from antiquity to the present day, as well as institutional and cultural factors shaping economic systems and determining development. Transfer of knowledge on the importance of integration for the economies of the member states, especially for Poland, and the essence of opportunities and threats resulting from economic integration.

On completion of the study programme the graduate will gain:

Knowledge: The student knows and understands the essence and main conditions of the functioning of the national economy and the basic processes of development of this economy; conditions for growth and development of the economy; the process of regionalization and globalization of the economy.

Skills: He is able to analyze and interpret the factors determining economic growth and development.
